1. Lead minor to Incheon to take part in the 17<sup>th</sup> Asian Games Incheon 2014 and lead the return trip;

2. Sign the Medical Consent and other documents as required by medical institutions, and/or provide relevant guarantees for the treatment of any disease or injury suffered by the minor;

3. Handle legal affairs on behalf of the minor;

4. Other guardianship responsibilities that shall be performed as the guardian.

(b) Olympic Council of Asia (OCA) and 2014 Incheon Asian Games Organizing Committee (IAGOC) will not assume any liability for any acts taken by the Chef de Mission for the performance of this acknowledgement.

(c) In case of the minor suffering loss or injury while receiving medical treatment, participating in the sports event and other official arrangements, the parent/legal guardian irrevocably exempt OCA, IAGOC, their respective staff, employees and volunteers from all liability.

(d) I unconditionally agree to use of the information related to this consent by OCA or IAGOC for non-
